As I was able to report last night at the DVRA meeting – all 38 pending tests in the skilled area were negative! Also, our one residential resident tested negative as well as the other 2 residential pending tests. We have 8 current cases in Skilled, one pending test in Personal Care, and 8 current employee cases. We can't tell you what a relief this brings to the staff and I am sure to the whole Dunwoody Community! Thanks to Dr. Lawrence for his leadership of our health care team – and to the health care team who have worked so hard to stop the spread! It's working!

Information for Independent Residents

In order to Vote online, You MUST have a valid license or state issued PA ID card with an ID number on it. If you do not have a state issued form of identification then you must fill out the form with the last 4 digits of their social security number and send it in to the Delaware county mail-in ballot office. All forms must be RECEIVED by the office by 5pm the Tuesday before the election (5/26/20) and completed ballots must be RECEIVED by the office by 8pm on election day (June 2). If you need the form or help, please contact Erin Price.

No transportation will be provided for the voting on June 2, 2020.

Library news:

A number of residents have expressed interest in having access to books and DVDs in the library. To accommodate these residents and still adhere to the regulations in effect at Dunwoody we have formulated a plan.

On May 14th by 10am residents in the Village should place outside their apartment door books and DVDs they have finished and wish to return to the library. These should be put in a plastic bag for pickup. A staff employee will collect the books. **Collection is limited to books from the Dunwoody Library.** We cannot accept books from other libraries. Penrose and Country House residents must call for pickup, 610-359-4425 and leave message.

If you wish to request other books from the Dunwoody library put a note in the bag with your name, telephone number, title, author and other information that would be helpful in filling your request. Let us know favorite authors, kinds of books you like, whether you prefer fiction or nonfiction, biographies, large print whatever will help us find good books for you to read or DVDs to watch. Library materials will be delivered to your door.

If this plan proves successful, we will continue collecting and distributing library materials on a regular schedule.
