Kathy is managing the (almost) daily memos to you and our website regarding COVID-19 along with all of the many other resident services she is organizing and providing. I, as I know that you do also, appreciate all that she is doing every day to try to meet your needs and bring you some sense of well-being through this difficult time.

Kathy has been working toward becoming a Nursing Home Administrator (NHA) this past year. The Pennsylvania Bureau of Professional Licensing has very specific requirements, including working under the auspices of an acting, licensed NHA.
