# **General Update**

## **Staff Testing:**

6/23/20 - 82 tested, 79 negative, 3 asymptomatic Positives, the employees that tested positive work in dining, nursing, and transportation and recovered at home. This round is complete. All staff has returned to work.

6/30/20 - 89 tested - 86 negatives, 3 Pending

7/07/20 - 53 tested - 26 negative - 27 pending

## **Care Center Update:**

We began our testing of all Personal Care Residents on Thursday 7/9/20, which must be completed before we can start the reopening steps.

### **Residential Updates:**
