General Update

Staff Testing:

6/23/20 - 82 tested, 79 negative, 3 asymptomatic Positives, the employees that tested positive work in dining, nursing, and transportation and recovered at home. This round is complete. All staff have returned to work.

6/30/20 – 89 tested – 89 negatives

7/07/20 – 53 tested – 53 negatives

7/14/20 – 73 tested – 73 negatives

7/18/20 – 23 tested – 23 negatives

7/21/20 - 29 tested – 29 Negative

Testing has been completed!

Care Center Update:

The reopening plans for Skilled and Personal Care have been posted on the website today, 7/27/20. They are posted as separate documents.

Residential Updates:

The notes from the Connie and Kathy show will be sent out tomorrow via Mail.

The pool will open on Tuesday, July 28th – if you want to make an appointment to swim, please contact the fitness center to get on the schedule. Tuesday and Thursday from 1-4 and Saturday from 9-1. 2 people at a time for 45-minute sessions.

Independent Living visitation - Below is the visitation plan for Independent living area. With cases climbing in our county over the weekend, it was decided to allow outside visits and indoor visits in common areas. See below for the criteria.

RE-opening plan for Independent residents:

Visitors are still discouraged, but are not prohibited.

At this time, we will allow outside visits and scheduled indoor visits in common areas. Visitation will begin on 7/29/20 for Independent living. We will be reviewing this weekly and will make changes as we can.

Outside Visits:

1. Limit of 2 visitors at a time.
2. All Visitors must wear masks and gloves (gloves will be provided at check in).
3. Visits will be for 45 minute increments in the areas around the building. Social circles may be longer – but please be respectful of others that may have guests or residents that want to use the social circles.
4. All visits need to be pre-scheduled with 24-hour notice. Please contact Marketing at 610-359-4425 to schedule your visit.
5. All visitors would check in at the reception desk to have temperatures taken and to fill out a screening questionnaire. Visitors would be asked to use hand sanitizer and given gloves to wear during the visit. The Front desk is locked at 7pm, so all visitors would need to be checked in before this time.
6. The visitors would be directed to their outside meeting point or taken to that spot by the resident. Social distancing of 6 feet is required. Areas will be set up for visitation around the front entrance (scheduled) and social circles may be used – but if residents are using the social circle we ask that you find another location. These will not be reserved and resident use takes precedence over visitation with families.
7. Children under the age of 16 are allowed to visit only when accompanied by an adult and they must be able to follow all safety requirements as outlined in this plan for visitors. All children must wear a mask at all times while at Dunwoody. Dunwoody Village strongly discourages visits by young children if they are unable to avoid excessive touching of rails, surfaces and other objects.
8. No visitation from any of the states that are currently needing to quarantine if they come to PA (current list set forth below).
9. Trash receptacles will be available outside to dispose of gloves once they are finished with the visit.

Please note that if we have any new cases in Independent living or we see a large increase in our county - visitation may be stopped.

Inside Visits

Due to the heat, we realize that visiting outside may be too uncomfortable and so we wanted to offer an inside visitation option.

1. Limit of 2 visitors at a time.
2. All Visitors must wear masks.
3. Visits will be for 45-minute increments. This gives us 15 minutes to turn the room over for the next set of guests.
4. All visits need to be pre-scheduled with 24-hour notice. Please contact Marketing at 610-359-4425 to schedule your visit.
5. All visitors would check in at the reception desk to have temperatures taken and to fill out a screening questionnaire. Visitors will be asked to use hand sanitizer.
6. The visitors would be directed to their meeting point or taken to that spot by the resident. 4 locations will be available - 2 locations in the Club room and 2 locations in the lounge. Seating and chairs will be set up prior to the visit and should not be moved. After the visit, the table and chairs will be cleaned.
7. Children under the age of 16 are allowed to visit only when accompanied by an adult and they must be able to follow all safety requirements as outlined in this plan for visitors. All children must wear a mask at all times while at Dunwoody. Dunwoody Village strongly discourages visits by young children if they are unable to avoid excessive touching of rails, surfaces and other objects.
8. No visitation from any of the states that are currently needing to quarantine if they come to PA (current list set forth below).
9. When you are finished your visit, we ask you use hand sanitizer on your way out.

Please note that if we have any new cases in Independent living or we see a large increase in our county - visitation may be stopped.
