GUIDELINES FOR VISITORS FOR INDEPENDENT LIVING

Dunwoody Village has arranged visits to take place either inside or outside, beginning July 29, 2020. In order to minimize the risk to all residents, we have established the following protocols for independent living. We will be reviewing these protocols regularly and will make changes as necessary. Additionally, if we have any new cases in Independent Living, or if we see a large increase in our county - visitation may be stopped.

Keep in mind that while residents traveling off the campus and inviting guests onto the campus is not prohibited, it is still discouraged. For those who choose to socialize off campus by going shopping, dining and visiting, please limit your socialization on campus so that others who have chosen to remain on campus are not compromised.

General Information:

- 1. All visits both inside and outside need to be pre-scheduled with 24-hour notice. Contact the Marketing office at 610-359-4425 to schedule your visit.
- 2. There is a limit of 2 visitors at a time.
- 3. All visitors (and residents) must wear masks.
- 4. Gloves are required for visitors and residents for outside visits (gloves will be provided at check-in).
- 5. Social distancing of 6 feet is required.
- 6. Children under the age of 16 are allowed to visit only when accompanied by an adult and they must be able to follow all safety requirements as outlined in this plan for visitors. All children must wear a mask at all times while at Dunwoody. Dunwoody Village strongly discourages visits by young children if they are unable to avoid excessive touching of rails, surfaces and other objects.
- 7. No visitation from any of the states that are currently needing to quarantine if they come to PA.
- 8. Per Dr. Lawrence, visitors are not permitted to go to residents' homes or patios.

Inside Visits:

- Inside visits can occur Monday through Friday between 9:00 a.m. and 5:00 p.m.
- 2. Visits will be scheduled in 45-minute increments. This gives staff 15 minutes to turn the room over for the next set of guests, if necessary.
- 3. All visitors would check in at the reception desk to have temperatures taken and to fill out a screening questionnaire. Visitors will be asked to use hand sanitizer.

- 4. The visitors would be directed to their meeting point or taken to that spot by the resident. 4 locations will be available 2 locations in the Club room and 2 locations in the lounge. Seating and chairs will be set up prior to the visit and should not be moved. After the visit, the table and chairs will be cleaned.
- 5. When you are finished your visit, we ask you use hand sanitizer on your way out.

Outside Visits:

- 1. Outside visits can occur Sunday through Saturday between 8:00 a.m. and 7:00 p.m. Weekend visits have to be reserved by noon on Friday.
- 2. All visitors would check in at the reception desk to have temperatures taken and to fill out a screening questionnaire. Visitors will be asked to use hand sanitizer and will be given gloves to wear, and will be directed to their meeting point or taken to that spot by the resident.
- 3. Visitation areas have been arranged under the canopy outside the Marketing Office and under the pergola in the Memorial Garden. Visits will be for 45-minute increments in these locations, to allow one group to leave before the other comes, if necessary.
- 4. Alternatively, social circles may be used for visits (they still require making reservations through Marketing as well as checking in at the reception desk). However, if other residents are using the social circle, we ask that you find another location. Resident use takes precedence over visitation with families.
- 5. Visitors do not need to re-enter the building before leaving; trash receptacles will be available outside to dispose of gloves once they are finished with the visit.
