## **General Update:**

## Care Center Update:

Residents in the Care Center, both Skilled (SK) and Personal Care (PC), may schedule appointments with the Dunwoody Beauty Salon. The salon will now take appointments for services beginning on Wednesday, August 12<sup>th</sup>, and will offer a full range of services. SK and PC residents will <u>not</u> be able to schedule appointments on the same day as we continue to try to minimize resident comingling from one level of care to the other. Cedars West and Cedars East residents will have barber and beauty services come to their respective units. Please contact the salon to schedule an appointment.
