General Update:

Covid-19 Testing: Last week 12 staff members were tested – 11 negative results and 1 positive. Staff member who tested positive was asymptomatic and is in isolation at home. The employee does not work in the Care Center and has not had contact with residents; this will not delay Skilled and Personal Care re-opening plans posted on the Dunwoody web-site.

Pet Policy: According to Dunwoody’s pet policy, residents are required to provide contact information for a pet to be transported to an emergency veterinary clinic at any time of day or night. Please make sure that the emergency contact information for your pet is updated and current. Due to the current COVID-19 crisis and restrictions on visitors (including family members) in your residence, it is important that this information is current in order to assure your pet’s care and safety. If you need to update your emergency pet contact information, please call Marketing at 610-359-4601.

Voting: The actual mail-in ballots will not be mailed to the voter until September or October. You may register on-line at www.votespa.com or print a mail-in or absentee ballot from that site. You can also check your voter registration and your ballot status from that site. See more information under Care Center and Residential. If you requested a mail-in ballot for the primary, checked the box to receive an annual mail-in ballot, and included your e-mail address, check your e-mail address for notification. Travel Update: According to the PA Department of Health, 5 states – North Carolina, Iowa, Nebraska, Utah, and Wisconsin – have been removed from Pennsylvania’s travel restriction list. The following 17 states remain on the restricted list: Alabama, Arizona, Arkansas, California, Florida, Georgia, Idaho, Kansas, Louisiana, Mississippi, Missouri, Nevada, North Dakota, Oklahoma, South Carolina, Tennessee, and Texas. Please avoid travel to these states and any areas that are identified as high-risk. If traveling to restricted states or high-risk areas, you must quarantine for 14 days upon return.
