Vaccine Update

Dunwoody's new pharmacy partner, Phoebe Pharmacy has received a regular supply of Pfizer vaccine and will be able to supply COVID-19 vaccines to Dunwoody residents and staff. Phoebe Pharmacy held its first on-site vaccine clinic on Thursday, April 8, 2021. The vaccination rate at our Community is high. The resident vaccination rate is 99%; staff rate is approaching 80%. Thank you to all who have made the decision to be vaccinated. Although our Dunwoody vaccination rate is high and our positivity rate is low, the Delaware County Positivity Rate is currently 8.6%, up from last week. Please follow CDC guidance as you go into the greater community. As you welcome family and friends onto our campus, please include the use of masks, social distancing and handwashing.

Visitation

Skilled Nursing, Woodlea and Leeland

Scheduled, outdoor visitation is available to all residents in Skilled Nursing, Woodlea and Leeland at this time. Please contact Jennifer Barrall at: 610-359-4503 to schedule an outdoor visit. Scheduled, compassionate visits are also available in skilled nursing on a case-by-case basis. To discuss compassionate visitation please contact your social worker. During inclement weather we will move outdoor visits to our safe visiting areas. You will be notified via telephone about any changes in visit location due to inclement weather.

Cedars East and Cedars West

Two employees who regularly work on our Cedars East and Cedars West units tested positive for COVID-19 on 4/12/21. Per regulation, we are required to close visitation on these units for 14 days. We will reopen outside visitation after 14 days barring any new positive COVID-19 cases. Compassionate visits will continue to be permitted on a case-by-case basis on Cedars East and Cedars West.

Last week we welcomed family and friends back to campus for visits in your home. It was great to see them back at Dunwoody! We appreciate the compliance of visitors who are checking in at the front desk to complete the necessary COVID-19 screening. Construction

This week on the construction project, the iron workers will come close to finishing the steel framing and decking on the east half of the addition. This will allow concrete to be poured for the second-floor slab and underground plumbing to begin installation for the ground floor, starting sometime next week. On the western half of the addition, the mason will continue to lay block at the new stair tower and should be close to finishing this week. They will also be laying block for the foundation walls of the new connector hallway. Once the mason is complete, the iron workers will move to the western side of the project and begin to erect the steel framework. Utility lines continue to be installed around the site. The plumber continues to work on under-slab plumbing in the existing building for the new prep kitchen and new mechanical room.
