#### **Covid-19 Vaccination to be Mandated for Employees:**

In order to be fully transparent, employees have been notified that Dunwoody Village will adopt a mandatory COVID-19 vaccination policy upon full FDA approval of the vaccine. Upon implementation of the policy, we will provide a reasonable window of time to comply (including ample time to process valid accommodation requests for medical or religious exemptions). Dunwoody Village continues to offer on-site vaccinations. We have also announced, effective immediately, that Dunwoody Village will only hire applicants who have received at least the first round of the Pfizer or Moderna vaccine, or the single dose Johnson & Johnson vaccine.

# **Construction Update:**

The main activity on the job this week is the continuation of drying-in roof area and completing wall sheathing. Once the sheathing is installed, a liquid water-resistant membrane is applied. This application is the blue "paint" product you can see in some areas. Inside the building, masonry walls are being built around the new kitchen and mechanical room areas, and door frames and interior metal stud framing are being installed.

<u>The West Country House connector hallway opening is delayed</u> because occupancy approval was not granted by the township upon inspection on Thursday June 24<sup>th</sup>. The needed modifications will be made by Tuesday June 29<sup>th</sup> and we will host a ribbon cutting ceremony for residents of West Country House at 10am on Wednesday June 30<sup>th</sup>. We are sorry for the delay!

#### WCH Changes – Meals & Mail:

With the delayed opening of the West Country House connector hallway, free meal delivery will now be discontinued to WCH on June 30<sup>th</sup>. Tuesday June 29<sup>th</sup> is the last date of free meal delivery. Coffee and Danish service will no longer be provided to the WCH after June 30<sup>th</sup>. Although U.S. postal mail will continue to be delivered, memos and in-facility mail will be placed in the Lobby Mailboxes beginning July 1st.
