Responsible Pet Ownership

According to Dunwoody's Pet Policy, pets are not permitted to roam freely in the hallways or public areas. At no time are pets permitted to accompany residents to any of the dining areas, including the Terrace, the buffet area, Gift Shop seating and the Auditorium that are in use for dining at this time. Pets (except for cat litter boxes in the residence) are not permitted to use indoors for relief. Residents must clean up after their pets and should be prepared to immediately pick up should the pet have an accident. Residents not capable of exercising or cleaning up after their pets must retain help to perform these tasks. Free roaming pets cause a risk to the health and safety of our residents. Health & Wellness

We currently have 3 Covid positive cases in independent living with several more residents in a modified quarantine due to exposures. Dr. Lawrence is recommending wearing masks at all times when outside your unit with the exception of when seated and eating a meal.

Notary Services

Notary services are available by appointment M-F 9:30 a.m. – 3:00 p.m. for Dunwoody residents. If the documents require witnesses, the resident must make arrangements for the witnesses to be present at the time of notarization, and witnesses other than Dunwoody residents who are personally known to the notaries must provide valid identification (a current driver's license or state/federal issued ID is preferable). *Dunwoody employees are not permitted to witness a resident's documents.* Do not sign or date your documents until you are in the presence of the notary. Please do not ask the notary to notarize blank documents; it is unlawful to do so. Notary services provided do not include real estate transactions and settlements. For notary services such as handicapped placard, power of attorney, or simple transactions, contact Kayla McFadden in Marketing or Josie Singer in Administration to arrange an appointment.

Construction

Kitchen equipment is being tested and inspected. Flooring is mostly complete, and final paint, finishes, and punch-list are ongoing. The excavator is grading the site, and the landscaper will be seeding and planting beds in the next couple of weeks.
