### **Mother's Day Brunch**

Reservation for Mother's Day Brunch will open on April 24<sup>th</sup> and can be made through Full Count. Seating times are 11:30am and 12:30pm. Guidelines for reservations are as follows:

- Maximum party size is 6 which includes residents and guests; larger parties cannot be accommodated.
- Residents will be charged 22 points.
- Your account will be charged \$25 for adult guests, \$15 for children 10yrs-12yrs, and \$10 for children under the age of 10.
- No points may be used for guests.
- All double reservations or parties of over 6 people will be cancelled.
