Campus Operations

Lower-Level Corridor Renovation

The flooring product has been received, and we are working through the logistics of the installation with the contractor. This work will be coordinated overnight to reduce the impact on traffic and corridor closures.

WIFI

We have identified the configuration issues and have a solution in place to address the compatibility between the new and old WIFI systems. We will be performing further testing next week and look to start the installation again the week of Monday, April 21st. The first locations of installation will be communicated next week. We will also be holding a town hall Q&A session next on Friday, April 18 from 2:00 – 3:00 pm to discuss the project and to answer any question you may have.

Putting Green

Pool

The equipment needed to repair the Pool HVAC is expected to be on site Monday, April 14th. We expect the repairs to be complete and the pool to be operational by the end of the week. We will distribute further announcements as we make progress.

Operations Restructuring

A Safety and Security Manager, Ted Cannon, will join Dunwoody on April 14th. We are actively recruiting for an Assistant Director of Campus Operations. The Assistant Director of Campus Operations will provide daily support and oversight of day-to-day operations and help develop systems and practices to enhance our services. Elevator 9

The work to repair elevator 9 in the Community Center will begin on Monday, April 14th. We expect this work to take between 3 and 4 weeks to complete and be tested for operation. We will distribute further announcements as we make progress.

Building and Grounds Committee

Brock Nichols will be meeting with some residents to discuss the Building and Grounds Committee. The goal is to work towards reactivating the committee to best serve the community and residents.

Speed Humps

We have determined 10 locations for new speed humps throughout the campus in efforts to help curtail speeding. We have reached out to our concrete vendor to coordinate this work. Once scheduled, we will communicate to the residents and staff about any impact on traffic during their installation. Please keep in mind, this is only one measure to help reduce speeding on campus. Speed humps alone will not reduce speeding, they are part of a larger safety plan which can include but is not limited to the following: signage, cameras and license plate readers, communication and reminders, issuance of violations, etc. We are working with our vendors to continue to improve our technology inside and outside of our community.

Inspections

Delaware County Department of Health was out to inspect the Kitchen and Community Common Areas/Restrooms on March 12th. No deficiencies were issued in either area. They did not inspect the Pool, we are expecting that in May or June (I believe that is what the inspector said).
